

# Judge/Trustee/341 Meeting Auto Assignment

Auto assignment is available for Chapter 7, Chapter 11, and Chapter 13. The automatic assignment feature automatically makes the following assignments after a case is opened:

- Judge
- Trustee, if applicable
- 341 meeting and related deadlines
- Chapter 13 confirmation hearings
- Divisional office assignment
- Judge for new adversary proceeding (same as judge for lead bankruptcy case)

## Requirements

- Case opened
- Creditors matrix uploaded

## How Auto Assignment Works

- If a **single case** is processed, the application searches the calendar entries that match the case's office and chapter, looking for the earliest time slot available.
- If a **group of cases** is processed, the application subdivides them according to the office/chapter combination and filing attorney. The systems looks at all trustees who take cases with that chapter to find one who can take all the cases on the same day.
- If the attorney chooses not to run the Auto Assignment feature, a program will run at night to make assignments to cases that were not assigned during the day.

## The Process

- STEP 1** Click the Bankruptcy hyperlink on the CM/ECF Main Menu.  
**(See Figure 1.)**



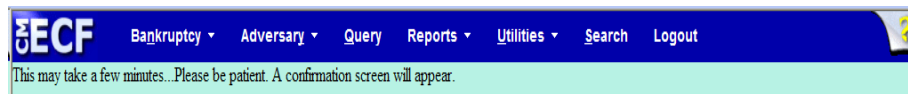

**STEP 2** The BANKRUPTCY EVENTS screen is displayed. (See Figure 2.)

- ◆ Click on the Judge/Trustee Assignment hyperlink. The program will run automatically. (See Figure 3.)

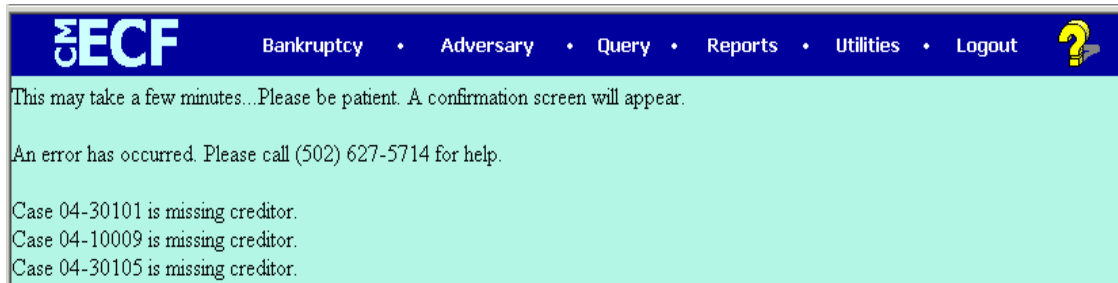
- ◆ A confirmation screen will appear listing the Judge, Trustee, if applicable, 341 Meeting and any related deadlines. (See Figure 4.)

## ssible Error Messages

**Error Message 1:** The creditors matrix must be loaded before running the Auto Assignment feature. Failure to load the creditors matrix will result in the following error message. (See Figure 5.)

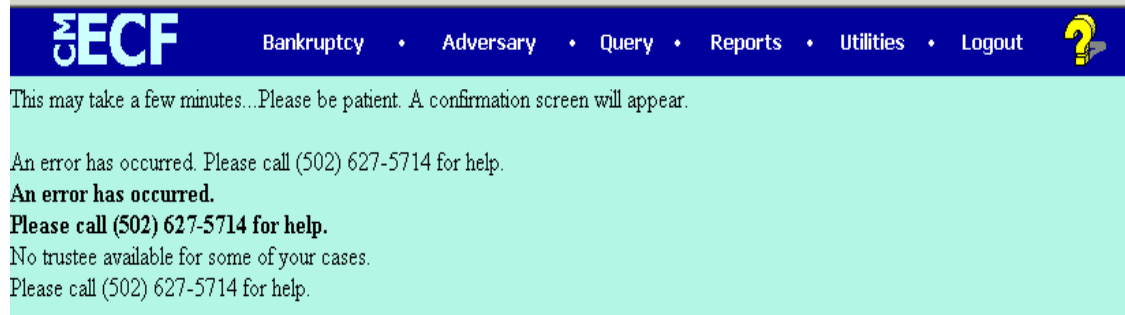

To correct the error message, load the creditors matrix:

- ◆ Click on the [Bankruptcy](#) hyperlink on the CM/ECF Main Menu
- ◆ Click on [Creditor Maintenance...](#) hyperlink
- ◆ Click on [Upload a creditor matrix file](#) hyperlink
- ◆ Select the case number and complete the process for attaching the creditors matrix
- ◆ Click back on the [Bankruptcy](#) hyperlink on the CM/ECF Main Menu
- ◆ Click on the [Judge/Trustee Assignment](#) hyperlink to re-run the program. A confirmation screen will appear listing the Judge, Trustee, if applicable, 341 Meeting and any related deadlines

**Error Message 2:** The second type of error message will direct the user to contact the court. The error message is the result of the calendar being completely full. The court will do a calendar adjustment to allow the scheduling of the cases through the Auto Assignment program. **(See Figure 6.)**
